## EXHIBITOR GUIDELINES

### 1. RENTAL SPACE

Rental space includes the following: 8' high back drape and 36" tall sideskirting. Exhibit spaces are in 10' x 10' increments. Displays of cars or chassis frames require a minimum of a double booth. The equipment supplied includes one 8' table, two chairs, and two exhibitor's passes. Electricity available upon request; please let us know in advance. For large displays such as race cars and trailers, you need to have your items in your booth on the first day of setup. Auction parts will be placed around all booths for maximum traffic.

### 2. BOOTH RENTAL AND PAYMENT SCHEDULE

A 50% deposit is required with the application. The balance is due and payable prior to set-up and prior to exhibitor passes being issued. Cancellation of registration prior to event subject to \$75 fee to cover trade show drape & associated event expenses.

### 3. EXHIBITOR AGREES

Exhibitor and his/her agents agree to abide by all times for set-up, show times, closing and tear-down. No exhibitor shall be allowed to remove any part of their exhibit until tear-down is officially permitted.

### 4. FIRE, HEALTH AND SAFETY REGULATIONS

Exhibitors agree to abide to all local, city and state laws, ordinances and regulations.

### 5. OPERATION

It is the exhibitor's responsibility to keep his exhibit open at all times during show hours. If for any reason the show management finds the method of operation, conduct, printed matter or any item of poor character which is considered questionable, that exhibit is subject to removal. No food or beverage may be sold. No alcohol permitted. The exhibitor shall confine his exhibit to his own booth space and not protrude beyond that space.

### 6. LIABILITY

The management will employ reputable guards and will take care to safeguard the exhibitor's property. However, the management will not be liable for loss or damage to the property of the exhibitor from fire, theft, accident or any other cause beyond its control. Exhibitor agrees to hold the exhibit hall owner, the show management, their agents or employees, free and harmless of all claims, demands, damages and liability.

### 7. REFUNDS

If the event management is prevented from holding the trade show by any cause beyond its control or if it can not permit an exhibitor to occupy his space due to circumstances beyond its control, the management will refund to the exhibitor the amount of rental paid by him, less a proportionate share of the trade show expenses.

### 8. SALES

The exhibitor may sell or offer for sale any new auto racing merchandise; Used merchandise must be consigned for sale in the auction. All sold merchandise must be verified by a sales receipt for security to allow customer's item removal from building.
